About this list

Requirement to provide list for tabling

This list of legislative instruments has been prepared for laying before each House of Parliament in accordance with section 52 of the *Legislation Act 2003* (the LA).

This list sets out the legislative instruments that are due to sunset (that is, to be repealed by section 50, 51 or 51A of the LA) on 1 October 2024.

Under subsection 52(2) of the LA, the Attorney-General must arrange for this list to be laid before each House of the Parliament on the first sitting day of the House on or after 1 April 2023.

This list was up-to-date when prepared on 7 March 2023.

To assist the reader, the instruments are grouped by administering department, consistent with the Administrative Arrangements Order as made on 13 October 2022.
